PARADE RULES:

Parade Rain or Shine!

- No live Santas- Santa will be the last entry of the parade!
- All entries must be lighted, Christmas-themed, and family-oriented. Only Christmas music is permitted.
- No throwing of anything from vehicles or off of floats (that includes candy, brochures and promotional items.)
- Anyone on horseback (or any animals submitted) must furnish cleanup behind them. No whip-popping is permitted. If your animal is not controlled, you will be removed from the parade.
- No hydraulic lifting of vehicles permitted.
- No political candidates permitted.
- An adult must supervise all children's groups.
- Any participant who does not cooperate with the parade Marshall or police officials or does not abide by these rules will be removed.
- No vehicle/float/etc should be more than 16' high.

Deadline for submission to the parade is Dec.9 at 4:00 PM. The parade will be limited to 100 entries.
